### Tools

# Accounts

These need clarifying. The balance for ECONET is around £400 but a fund of £2,000, mainly from tree sales, is still held by FoCC and will be transferred to ECONET (see Brush Cutter). There was clarification of what are ECONET expenses and what Friends groups should pay for.

The value of a purchase has always been in some doubt and it is now clear that there is no need. Funds were set aside after the disappearance of the reciprocal cutter at Waterloo Meadows. This site and View Island, at least, would have benefited but new RBC machinery enables RBC to do the work. If there is a need for groups to use such machinery training courses could be arranged.

### **RBC Matters**

There has been reorganisation of job specifications since Beverley took maternity leave. David Booth has been appointed in a new post, he is to cover Beverley's duties and will from now on be the first point of contact for the groups. Use of the Centre and of RBC facilities, notably the truck, must be booked through David. He will also, in time, meet groups and give support with funding.
